This Act generally prohibits and punishes all forms of human trafficking, though it does not flatly prohibit the fraudulent recruitment of labor migrants; rather, the Act requires the recruiter to have known that the recruited workers would be subject to forced labor. The TVPA, as amended, requires that a country on the special watch list in practice, the Tier 2 Watch List for two consecutive years be subsequently listed among those whose governments do not fully comply and are not making significant efforts to become compliant Tier 3.
